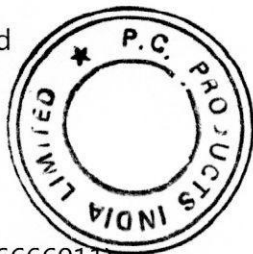

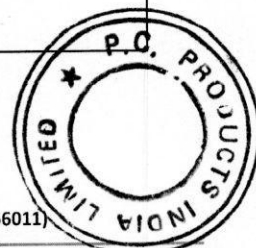

Review Report to M/s. PC Products India Limited, Hyderabad.

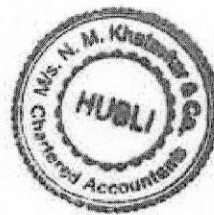
