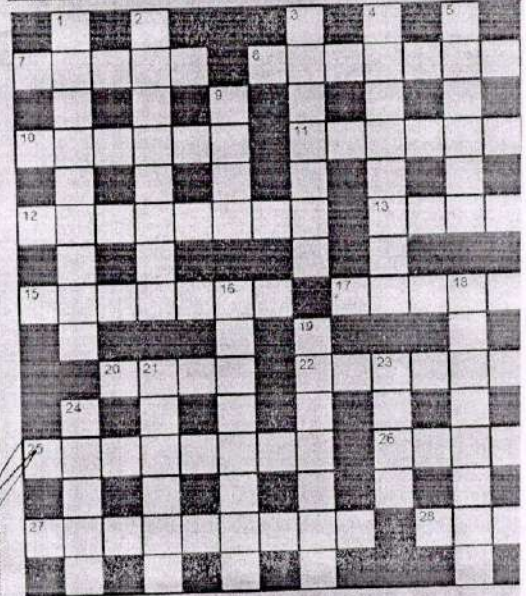
According to the Board of Control for Cricket in India (BCCI), the list sent out to the franchises includes 281 capped players and 838 uncapped play-

ers and three player Associate Nations (countries that do not qualify for membership with International Cricket Council)

Of the 1,119 players auction pool, 282 are overseas players. These include Australian players, 57 African players and 5 from West Indies and Sri Lanka. From the Associate Nations, two players from Scotland and one player from the United States have registered for the auction this year.

The bigger purse attached to the disposal of the franchises, worth a million as compared to the million last year, has added to the excitement.
